# **ASSISTANT PROPERTY AUDITOR APPRAISER**

# QUALIFICATIONS

## Either I

One year of experience in California state service performing property appraisal or auditing duties of a class equivalent to a Tax Auditor. (Applicants who are within six months of meeting this requirement will be admitted to the examination but must satisfactorily meet this requirement before they can be considered eligible for appointment.)

## Or II

Experience: Either

1. One year of experience in an assessor's office auditing and appraising personal property and fixtures of commercial or industrial firms or utilities; or
2. Two years of experience auditing records of commercial or industrial firms or utilities.

## AND

## Either I

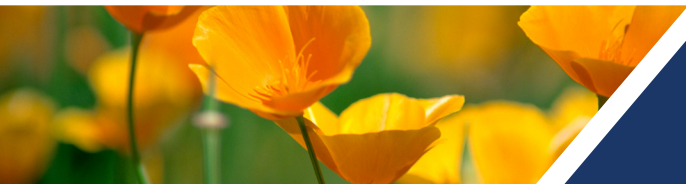
Education: Equivalent to graduation from college.

## Or II

Completion of either:

- a. A prescribed professional accounting curriculum given by a residence or correspondence school or accounting, including courses in elementary and advanced accounting, auditing, cost accounting, and business law; or
- b. The equivalent of 19 semester units, 16 units of which must have been professional accounting courses given by a collegiate-grade residence institution, including courses in elementary and intermediate or advanced accounting, auditing, and cost accounting, and three semester units of business law.

(Additional qualifying experience may be substituted for the required education on a year-for-year basis. Substitution is not permitted for the specific college course work required under b above.)



## Typical Responsibilities

The Assistant Property Auditor Appraiser provides great potential for personal development and career advancement. Incumbents collaboratively conduct the less complex audits and/or field investigations of small and medium-sized industrial and commercial properties. Incumbents will be a member of a survey team, traveling throughout California to assist with a wide range of audit assignments, and challenging property tax research projects. You will have support from your team members and supervisor. The incumbent will also gain knowledge of general appraisal methods, procedures, and terminology; and real property law and common methods of describing property; knowledge of specialized practices and procedures used in property appraisals; provisions of Property Tax laws administered by the State Board of Equalization; purposes, organization, and procedures of assessors' offices; departmental policies, rules, and regulations; and organization of the State Board of Equalization, particularly the Property Tax Program.

The successful candidate will be part of a survey audit team with oversight of all 58 County Assessors' offices. Your experience may include the following:

- ▶ Travel throughout California up to 50 percent of the time.
- ▶ Participate in meetings with County Assessors and staff.
- ▶ Audit Assessor's records and report findings via written reports.
- ▶ Make recommendations for tax law compliance.
- ▶ Work as a team or independently.
