## COUNTY ASSESSMENT APPEALS FILING PERIOD FOR 2019

The clerks of the county assessment appeals boards and boards of equalization have complied with the requirements of Revenue and Taxation Code section 1603 by certifying the last day of the assessment appeals filing period for their counties. The regular appeals filing period will begin on July 2, 2019 in each county and will end either on September 16 (September 15 falls on a Sunday) or December 2 (November 30 falls on a Saturday), depending on whether the county assessor has notified the clerk of the board of his or her intent to mail assessment notices by August 1, 2019, to all taxpayers with property on the secured roll.

The regular appeals filing period will begin on July 2, 2019 in each county and will end either on September 16 (September 15 falls on a Sunday) or December 2 (November 30 falls on a Saturday), depending on whether the county assessor intends to mail assessment notices by August 1, 2019, to all taxpayers with property on the secured roll.
