**INSTRUCTIONS**

- Column B Enter the number of miles, by county, of private shared ROW. (Multiply Column E by Column F)
- Column C Enter the number of miles, by county, of private ROW (not shared) and any taxable possessory interest not located in a public street or highway.
- Column D Total number of miles by county (add Columns A, B, and C)
- Column E Enter route miles of private shared ROW by county.
- Column F Enter the percent of property interest by county.
- Grand Total Enter the grand total of California ROW miles (total each column).

Refer to the Fiber Optic Classification Matrix located in the **Instructions for Reporting State-Assessed Property** publication to aid in the completion of this form.

\*Privately shared ROW is a ROW in which more than one ownership interest exists.  
 \*\*Partial interest exists if you have less than 100 percent property interest in private ROW and/or possessory interest.
