

➤ **Example 1: EDI Petroleum Carrier Report Data for Pipeline A Company**

This example illustrates the movement of reportable products by Pipeline A Company. The pipeline moves product from Terminal 1 to Terminal 2 and on to Terminal 3, which is located outside the state. Product movements include gasoline (Product Code 065), diesel fuel (Product Code 167), jet fuel (Product Code 130) and kerosene (Product Code 073). The pipeline also serves a user (Electric Company or Airport on diagram shown on page 2) with a direct connection to the pipeline. The user does not require registration as a terminal operator because the user's facility does not have a terminal rack.

The actual file, unlike the EDI example below, will be a continuous stream of data without carriage returns, blank lines or line numbers.
