Matthew -

NOTICE: This email is being sent from Jane's computer at home. Any response should be sent to my office email address.

I'm sorry to be the bearer of bad news, but after some sleuthing I finally found a Franchise Tax Board employee [Vicki Robinson] who -- after I supplied her with a power of attorney authorizing me to receive such confidential information on your behalf -- supplied me with the facts set forth on the attached breakdown respecting late-and-underpaid taxes for 2007 and 2008 and respecting the myriad late fees, penalties, interest, lien releases, etc. which in the aggregate add up to the \$4,502.93 now needed to be paid on or before June 28 in order to revive the corporation.

You may find these calculations difficult to understand, as do I. If you or your accountant want to discuss them with Vicki, she can be reached at a Sacramento telephone number that I have written down in my office, where I can be reached after 8:30 (but no later than 11:30) tomorrow morning.

X In order to procure a certificate of revivor, your check for the total due should be delivered ASAP to the Franchise Tax Board office in San Francisco (121 Spear Street, room #400) and you should get a receipt for that payment to me this week if possible. I'll then fax an application for revivor to Vicki, including a copy of that receipt. This should do the trick.

X You also have only two more weeks to file this year's Statement of Information for this corporation. That Statement, along with a \$25.00 fee, goes to the Secretary of State. Missing this due date will cost an extra \$350.00.
