Subject: **2011 Hazardous Substances Program Fees And Occupational Lead Poisoning Prevention Fee**
(September 2010 Administrative Consent Calendar)

In accordance with the Health and Safety Code Sections listed below, the Hazardous Substances Program Fees and the Occupational Lead Poisoning Prevention Fee are adjusted each year by the incremental change in the Consumer Price Index (CPI) published by the California Department of Industrial Relations. The increase in the CPI from June 30, 2009 to June 30, 2010 is 0.942 percent and was calculated as follows:

CPI @ June 30, 2010	227.113
CPI @ June 30, 2009	224.994
Increase in CPI	2.119
Percentage Increase	0.942%

I recommend that the 2011 fees for the Hazardous Waste Programs and the Occupational Lead Poisoning Prevention Program be established according to the attached schedules identified as Exhibits A – D:
