

Pursuant to Revenue and Taxation Code Section 155, this constitutes an official request for a thirty [30] day extension for completion of the 2016 Secured and Unsecured Assessment Rolls.

There are hundreds of structures damaged by the Butte Fire that will require our immediate attention. Based on our staffing levels and projected workload, it is unlikely that we will be able to complete all of the tasks necessary to produce the assessment roll by July 1st.

Additionally, I ask for your understanding with the requests for information that the BOE regularly makes from assessors. It is likely that we will be late submitting the Budget, Staff, and Workload report and I anticipate the same problems with other complicated reports such as the Sales Ratio Study.

We respectfully request an extension to complete the 2016 roll. Thank you for your favorable consideration of this request.
