

The taxpayers' residence is thousands of miles away from the activity




Dec. 31, 2006 – Jan 2, 2007 Appellants
charged Kalow \$550 per night:
a total of \$1,650


Dec. 30, 2007 – Jan 4, 2008 Appellants
charged Kalow \$550 per night:
a total of \$3,300

- While Appellants also claimed to have worked on their Personal, Separate Apartment an average of 24-28 hours per day during both of Kalow's stays

Virginia Beach is 220 miles away



Jan 2, 2007– Appellants Claimed 12 Hours for Cleaning Personal Apartment, Despite Renter Overlap and Travel to Atlanta/San Jose



*This based on a 24 hour day and assumes that Appellants did not encounter any traffic on their way to Atlanta, GA and did not make any stops for meals, gas, or rest. It also assumes that the flight to San Jose, CA did not have any stops or layovers and that Appellants did not spend any time getting ready, packing their bags, or loading the car.
