Subject: **2008 Diesel Fuel Tax Rate for Interstate Users**
(September 12, 2007 Administrative Consent Calendar)

Beginning January 1, 1998, and on each January 1 thereafter, sections 60115 and 60116 of the Revenue and Taxation Code provide that a (two-component) diesel fuel tax shall be established by the Board. (A history of the rate since its inception is attached.) This tax is imposed on all interstate users for the privilege of using diesel fuel purchased without California sales tax to propel a qualified motor vehicle in California.


The first component of the tax is \$0.18 per gallon (§60050). The second component (§60116) is a cents per gallon component equivalent to the sales tax on the average selling price of diesel fuel purchased in California during the prior twelve-month period ending August 31. I recommend the adoption of a diesel fuel tax rate of \$0.366 per gallon for calendar year 2008. The rate was developed as follows:

\$ 2.952	Average price per gallon of diesel fuel including state excise tax and sales tax for the period 9/7/06 through 8/29/07.
- 0.180	State excise tax.
2.772	Average price per gallon excluding state excise tax.
- 0.204	Sales tax amount included in average price per gallon (\$2.772/1.079432 = \$2.568. \$2.772 - \$2.568 = \$0.204).
2.568	Average price per gallon excluding state excise tax and sales tax.
x .0725	Combined state and local sales tax rate.
0.186	Second component of the interstate users' tax on diesel fuel.
+ 0.180	First component of the interstate users' tax on diesel fuel.
<u>\$ 0.366</u>	Recommended diesel fuel tax rate rounded to the nearest tenth of a cent.
