Free Income Tax Return Preparation at VITA Locations in Ventura County

Sacramento – Individuals and families who need help with income tax return preparation can visit Volunteer Income Tax Assistance (VITA) locations in Ventura County.

“This program provides free tax preparation to individuals and families who may not be able to afford a tax preparer. Connecting qualified earners with the Earned Income Tax Credit provides them with valuable support during difficult economic times and boosts our state and local economy,” said Runner.

The federal government is offering up to \$5,891 in Earned Income Tax Credits (EITC) to households earning less than \$50,270 annually. Free VITA events throughout California help qualified taxpayers receive much needed federal and state tax credits. Every year, VITA volunteers who have been trained and certified by the Internal Revenue Service (IRS), offer free tax filing assistance.

Qualifying individuals and families can obtain free tax preparation assistance at select schools, community centers, and nonprofit organizations throughout California.
