


LOCATION

From Los Angeles Area:

Take 10 East
 Connect with 15 South
 Connect with 60 East
 Exit Market Street, turn right
 Go to 5th Street, turn left
 Riverside Convention Center is on the left,
 next to the Marriott.

From Palm Springs Area:

Take 10 West to 60 West
 Exit Market Street, turn left
 Go to 5th Street, turn left
 Riverside Convention Center is on the left,
 next to the Marriott.
