Staff of the State Board of Equalization (BOE) will hold an interested parties meeting to discuss proposed revisions to form BOE-502-AH, *Change in Ownership Statement (COS)*, and form BOE-502-A, *Preliminary Change of Ownership Report (PCOR)*. The process was initiated in response to a request from the California Assessors' Association Forms Subcommittee to make various changes to Part 3 on each form and to create instructions for each form. Additionally, BOE staff added a question regarding the new cotenancy exclusion pursuant to the provisions of Assembly Bill 1700 (Stats. 2012, ch. 781) which added section 62.3 to the Revenue and Taxation Code effective January 1, 2013.
