TO COUNTY ASSESSORS:

REVENUE AND TAXATION CODE SECTION 69.5 ORDINANCES

Effective February 15, 2010, the following eight counties will have ordinances implementing the intercounty base year value transfer provisions of section 69.5 of the Revenue and Taxation Code for persons age 55 and over and severely and permanently disabled persons (Propositions 90 and 110):

Alameda	Los Angeles	San Diego	Santa Clara
El Dorado	Orange	San Mateo	Ventura

Since our last letter on this subject (Letter To Assessors 2007/020, dated April 9, 2007), the El Dorado County Board of Supervisors voted on December 15, 2009, to enact a section 69.5 intercounty ordinance. El Dorado County's ordinance will take effect on February 15, 2010 and will remain in effect for five years. We will notify you if we become aware of any changes in these ordinances. Continued cooperation from the counties in notifying our Assessment Services Unit when an ordinance is adopted or repealed is appreciated.
