INTRODUCTION

The purpose of this report is to supply data that are useful for comparing the operations of an assessor's office with those of other county assessors.¹ Possible uses for the data contained in this report are management/staff planning and budget development.

We would like to caution the reader to use care in comparing data contained in this report. The 2013-14 assessment roll is based on workload experienced in an earlier assessment year. For example, income, expenses, budgeted positions, and workload reported all relate to the 2013-14 fiscal year. However, the 2013-14 roll was prepared in the 2012-13 fiscal year using budget and staff for that year.

These data were compiled by the Board's Property Tax Department, County-Assessed Properties Division, from responses to questionnaires sent to all assessors. Please note that the figures and totals in this report may be incomplete in that they represent a comparison of *furnished data only*. Fifty-four of the fifty-eight counties reported data; Mendocino, Santa Cruz, Sierra, and Tulare Counties did not provide data.

Please note that the number in parentheses, below the column category, represents the corresponding question number in the questionnaire, CAO 2014/017, dated August 20, 2014.
