Notes:

- (1) Fiscal Year reports year ending in column year. Example, FY00/01 is reported in the column for 2001.
- (2) The 2001 figures have been revised to include all late or amended returns that remained unaccounted for when the September 2002 reports were prepared. The total adjustment to the 2001 monthly figures is 168,110,749 gallons. This adjustment is a one-time adjustment that will not be necessary in future years due to the change in the method of data collection and preparation of this report.
- (3) Above figures reported net of BOE audit assessments, refunds, amended/late returns and State Controllers Office refunds.
- (4) This report was created on 10/30/02. Conversion of data collected prior to January 2000 from "gross" to "net", was deemed impractical.
- (5) This report replaces the *Gross Taxable Gasoline Gallons (Including Aviation Gasoline)* report which will not be produced after December 2002.
- (6) The November 2007 figures include 14.6 million gallons in refunds.
The December 2007 figures include 54.2 million gallons in audit assessments.
- (7) The February 2008 figures include 71.0 million gallons in audit assessments.
The July 2008 figures include 19.4 million gallons in audit assessments and amended returns.
The September 2008 figures include 13.3 million gallons in audit assessments.
