

Driving Directions

From Fullerton:

- Take CA-91 East
 - Merge onto CA-57 South towards Santa Ana
 - Take the I-5 South/Santa Ana exit on the left
 - Keep left, follow signs for Main Street South
 - Keep left and merge onto I-5 South
 - Take the Jamboree Road exit
 - Turn right onto Jamboree Road
 - Turn left onto Barranca Parkway
 - Turn right onto Harvard Avenue
 - Turn right onto Civic Center Plaza
- Destination will be on the left*

From Dana Point:

- Take I-5 North
 - Keep right at the fork to continue on the I-405 North
 - Take the Culver Drive exit
 - Turn right onto Culver Drive
 - Turn left onto Alton Parkway
 - Turn right toward Civic Center Plaza
 - Turn right onto Civic Center Plaza
- Destination will be on the right*
