1. Head south on I-15 S
2. Slight left at I-215 S 10.9 mi
3. Take exit 43 toward 3rd St W/2nd St W 0.1 mi
4. Merge onto N I St 446 ft
5. Turn left at W 3rd St 0.3 mi
6. Continue onto W 4th St 0.4 mi
7. Turn right at N D St
Destination will be on the right 0.1 mi

From the South:

1. Head north on I-215 N toward Exit 25
2. Take exit 34A to merge onto I-215 N toward San Bernardino/Barstow 9.0 mi
3. Take exit 43 for 2nd St toward Civic Center 0.1 mi
4. Turn right at W 2nd St 0.5 mi
5. Turn left at N D St
Destination will be on the left 0.1 mi

From the East:

1. Head northwest on I-10 W toward Exit 90
2. Take exit 72 to merge onto I-215 N toward San Bernardino/Barstow 3.1 mi
3. Take exit 43 for 2nd St toward Civic Center 0.1 mi
4. Turn right at W 2nd St 0.5 mi
5. Turn left at N D St
Destination will be on the left 0.1 mi

From the West:

1. Head southeast on I-10 E
2. Take exit 72 to merge onto I-215 N toward San Bernardino/Barstow 3.1 mi
3. Take exit 43 for 2nd St toward Civic Center 0.1 mi
4. Turn right at W 2nd St 0.5 mi
5. Turn left at N D St
Destination will be on the left 0.1 mi
