[3-4](#) Add Section 6358.3 to, and repeal Section 6018.1 of, the Revenue and Taxation Code to provide that the use, furnishing, or sale of drugs and medicines, as defined, by a licensed veterinarian, city, city and county, county, or other local government animal shelter, or a nonprofit animal welfare organization are exempt from tax, when used, furnished, or sold for the treatment of animals.




