Upon motion of Ms. Stowers, seconded by Mr. Vazquez and unanimously carried, Mr. Vazquez, Mr. Schaefer, Ms. Cohen and Ms. Stowers voting yes, Mr. Gaines absent, the Board adopted the language as to issue 3, option 1, with changes suggested by the Clerks and Santa Clara County and agreed upon by the Workgroup members.

Upon motion of Mr. Vazquez, seconded by Mr. Schaefer and duly carried, Mr. Vazquez, Mr. Schaefer and Ms. Cohen voting yes, Ms. Stowers voting no, Mr. Gaines absent, the Board approved issue 2 as agreed upon by the Workgroup members to conceptually request BOE staff to provide guidance that encourages all parties to meet before the appeals hearing, as well as for those counties that have a meet-and-confer process, to leverage those processes as it relates to assessment appeals matters, using the discussion earlier in the day on how to achieve this in the guidance.

Upon motion of Mr. Vazquez, seconded by Mr. Schaefer and unanimously carried, Mr. Vazquez, Mr. Schaefer, Ms. Cohen and Ms. Stowers voting yes, Mr. Gaines absent, the Board adopted the language as to issue 1 as agreed upon by the Workgroup members.
