
Pursuant to Section 155 of the California Revenue and Taxation Code, a request hereby is made for a 30-day extension of time for delivery of the Orange County Assessment Roll to the County Auditor-Controller. We are requesting an extension from July 1, 2011, to July 31, 2011.

This extension of time is necessary due to a combination of (1) substantial amount of Proposition 8 value reduction review workload due to the market conditions, (2) staffing shortage resulting from budget reductions and hiring freeze imposed by the county, and (3) impact from the ongoing effort to re-engineer our legacy mainframe assessment systems.

The extension will allow us to prepare an assessment roll in accordance with current property tax laws.
