# *Taxable Sales In California (Sales & Use Tax)*

*2013 First Quarter*

*Taxable Sales in California* is a quarterly report on retail sales activity in California, as measured by transactions subject to sales and use tax. The report includes data about statewide taxable sales by type of business as well as data about taxable sales in all California cities and counties.

The following factors should be considered when using these data:

1. Total taxable transactions do not necessarily indicate the gross sales of stores dealing in taxable items. Only sales subject to sales or use tax are tabulated; excluded are sales for resale, sales of nontaxable items such as food for home consumption and prescription medicines, and taxable sales disclosed by Board audits.
2. Some businesses dealing primarily in nontaxable activities, such as services, manufacturing, contracting, or wholesaling, either sell some merchandise that is subject to sales tax or use some items that were purchased ex-tax and on which use tax must be paid. Such transactions are included in the tabulations.
3. Data are compiled by type of store but cannot be broken down by commodity.
4. Businesses are classified according to their principal line of merchandise or service.

# TAXABLE SALES IN CALIFORNIA

## FIRST QUARTER 2013

California taxable sales increased 5.5 percent in the first quarter of 2013, down from 7.4 percent growth in the fourth quarter of 2012. First quarter 2013 taxable sales totaled \$135.4 billion, \$7.0 billion more than taxable sales in the first quarter of 2012. Taxable sales increased much faster than the 2.6 percent increase in California personal income in the first quarter.

In constant dollar terms, first quarter 2013 taxable sales grew at 5.2 percent. The California Taxable Sales Deflator, which measures the rate of change of all taxable sales in the state, was up only 0.2 percent over the same quarter last year. The California Consumer Price Index, which measures price changes of both taxable goods and nontaxable goods and services, grew much faster, 2.1 percent. Decreases in gasoline prices were a major factor in keeping the deflator growth low.

Taxable sales made by Retail Stores and Food Services grew at 6.3 percent, accounting for 69.3 percent of total taxable sales in the first quarter of 2013. Nonretail Outlets (all other outlets) grew at 3.7 percent, and comprised the remaining 30.7 percent. Nonretail taxable sales include items such as business equipment and construction materials.

Motor Vehicles and Parts had more taxable sales than any other retail business,

\$15.9 billion, followed by Food Services and Drinking Places at \$14.9 billion. The next largest retail business was Gasoline Stations at \$13.9 billion.

Sales made by Clothing and Clothing Accessories Stores had the fastest growth of any major type of store, rising 12.9 percent. Taxable sales made by Motor Vehicles Dealers were among the fastest growing large retail categories, rising 8.6 percent. Sales were strong at both new car dealers and used car dealers. Decreases in gasoline prices resulted in a 1.4 percent decrease in taxable sales at Gasoline Stations, the first reduction since 2009.

Taxable purchases made by construction companies were increasing along with California housing activity. Construction sales (a non-retail business) rose 22.5 percent to \$2.3 billion. Retail Building Materials and Garden Equipment and Supplies Store sales rose 10.4 percent to \$6.9 billion.

The Northern Sacramento Valley Region had the fastest growth of any major region, with taxable sales rising 8.6 percent, followed by the Sacramento Area at 7.8 percent. Both Southern California and the San Francisco Bay Area had below average growth, 4.9 and 5.1 percent.

**FOOTNOTES**

a/ Per capita taxable sales were derived by dividing first quarter self-assessed taxable sales by the population estimates of the State Department of Finance for January 1. The populations used were 37,668,804 for 2012 and 37,984,138 for 2013.

b/ Some permittees, by the nature of their business, are not required to allocate local sales or use tax to specific local jurisdictions. Their taxable transactions are listed under the column headed "Unallocated" in Table 2. Contractors and manufacturers generate most of the countywide unallocable transactions through construction work and making installations of manufactured products in the various counties. Unallocated taxable sales are not reported in Tables 5 and 6.

**Notes concerning permits:**

A sales tax permit is required for each place of business operated by all manufacturers, wholesalers, and retailers of tangible personal property except those dealing solely in nontaxable commodities. Permits are tabulated twice a year: as of January 1 and July 1.
