TAXABLE STATUS OF CERTAIN INSURANCE COMPANIES^{*} PERSONAL PROPERTY

We have previously informed you that insurance companies pay a gross premiums tax which is in-lieu of property taxes on their personal property. This information is correct, providing the insurance company actually pays a gross premiums tax. However, we have recently become aware that certain insurance companies are exempt from the gross premiums tax and all other state and local taxes, except taxes on real estate and office equipment. There are two types of insurance companies in this category. The first group is nonprofit hospital service corporations, and the second is fraternal benefit societies.

Nonprofit Hospital Service Corporations

The Insurance Code, Section 11493.5, declares nonprofit hospital service corporations to be charitable and benevolent institutions and exempts all their "funds" from all state and local taxes except taxes on their real estate and office equipment. We are aware of only three such corporations in California:

Fraternal Benefit Societies

In a similar provision, Section 10993 of the Insurance Code declares fraternal benefit societies to be charitable and benevolent institutions and exempts their funds from all state and local taxes, except taxes on their real estate and office equipment.
