BACK: Certification changed; one signature of transferee deleted; signature requirements deleted for additional transferor(s) and transferee(s).
- **BOE-58-G, *Claim for Reassessment Exclusion for Transfer From Grandparent to Grandchild***  
FRONT: Language changed in "IMPORTANT" paragraph; "Certification" section deleted.  
BACK: Certification changed; signature requirements deleted for additional transferee(s).
- **BOE-64, *Claim for Seismic Safety Construction Exclusion from Assessment***  
FRONT: Change in filing requirements.  
BACK: Change in filing requirements, second paragraph; wording of paragraph (2) changed.
- **BOE-261-GNT, *Disabled Veterans' Exemption Change of Eligibility Report***  
Change 2001 to 2002 at two places on the front and four places on the back.
- **BOE-571-C, *Power Plant Property Statement***  
On pages S3B and S4F, change the years on the left side column by adding one year to each.
