## GUIDELINES FOR APPRAISER CERTIFICATION AND TRAINING

Staff in the Assessment Policy and Standards Division are beginning the development of Guidelines for Appraiser Certification and Training. The purpose of this project is to develop standards for processing of applications for appraiser certification and approval of training requirements.

After suggestions are received, it is anticipated that the project will proceed as follows:

- Staff will meet with interested parties on August 13, 2003, to discuss proposed changes to the draft. Staff will distribute an agenda matrix prior to the meeting.
- Staff will submit an issue paper and other required documents for the October 15, 2003 Property Tax Committee meeting. The committee will hear discussion of any unresolved issues regarding the guidelines.
